

# PRIVACY POLICY

Effective: 18 December 2012

MOTORNET TECHNOLOGIES Ltd (also referred to as "MOTORNET TECHNOLOGIES", "we", "us" throughout this document), an electronic based business suite for practicing and potential Real Estate Professionals is committed to protecting your privacy and developing technology to give you a powerful and safe online experience.

This Statement of Privacy applies to the MOTORNET TECHNOLOGIES website [www.prime-exchange.net](http://www.prime-exchange.net) and governs data collection and usage. By using the MOTORNET TECHNOLOGIES website, you consent to the data practices described in this statement.

## Collection of Your Personal Information

MOTORNET TECHNOLOGIES collects personally identifiable information, such as your email address, name, home or work address or telephone number and a pin. MOTORNET TECHNOLOGIES also collects anonymous demographic information, which is not unique to you, such as your ZIP/Postal code, age, gender, preferences, interests and favourites.

MOTORNET TECHNOLOGIES collects certain types of personally identifiable information from businesses such as Company name, location address, contact person, position, phone number, email address, valid ID document type and number, registered date of the company, and a pin.

We may collect information about third parties from you such as details of names, email addresses, and date of birth data. The information is requested for the purpose of nominating a beneficiary for your Agency with MOTORNET TECHNOLOGIES or for shipping purpose. There is also information about your computer hardware and software that is automatically collected by MOTORNET TECHNOLOGIES. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used by MOTORNET TECHNOLOGIES for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the MOTORNET TECHNOLOGIES website.

Our Web site offers publicly accessible blogs or community forums. You should be aware that any information you provide in these areas may be read, collected, and used by others who have access to them. ## Use of Your Personal Information

MOTORNET TECHNOLOGIES collects and uses your personal information to help you operate the MOTORNET TECHNOLOGIES website and deliver the services you have requested, such as allowing you to keep track of new referrals, customer purchases and payments, account balances, transactions, activity and performance and commissions. MOTORNET TECHNOLOGIES also uses your personally identifiable information to respond to your inquiries, allow you to subscribe to RSS feeds, newsletters, articles, updates, and inform you of other products or services available from MOTORNET TECHNOLOGIES and its affiliates. MOTORNET TECHNOLOGIES may also contact you via surveys to conduct research about your opinions of current services or of potential new services that may be offered. We may require you to provide us certain demographic information. We will also use this information to monitor site traffic and personalize the site.

MOTORNET TECHNOLOGIES collects and uses your personal information to create your business account and allow you to sell items on the site to individuals, delivering services you have requested. We may also use your information to send you relevant newsletters, respond to your inquiries, allow you to subscribe to RSS feeds, newsletters, articles and updates. MOTORNET TECHNOLOGIES does not share, sell, rent or lease its customer information lists to third parties other than as disclosed in this privacy policy. MOTORNET TECHNOLOGIES may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (email, name, address, telephone number) is not transferred to the third party. In addition, MOTORNET TECHNOLOGIES may share data with trusted partners to help us perform statistical analysis, send you email or postal mail, provide customer support, process payments, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to MOTORNET TECHNOLOGIES, and they are required to maintain the confidentiality of your information. If you no longer wish to receive email offers, newsletters, articles, or updates you may opt-out at any time by using the unsubscribe link located at the bottom of each communication, or simply by emailing us at [privacy@prime-exchange.net](mailto:privacy@prime-exchange.net).

We may also disclose your personal information as required by law, such as to comply with a subpoena, or similar legal process, when we believe in good faith that disclosure is necessary to protect our rights, to protect your safety or the safety of others, investigate fraud, or respond to a government request.

If we are involved in a merger, acquisition, or sale of all or a portion of our assets, you will be notified via email and/or prominent notice on our website of any change in ownership or uses of your personal information, as well as any choices you may have regarding your personal information.

MOTORNET TECHNOLOGIES does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

MOTORNET TECHNOLOGIES keeps track of the websites and pages our customers visit within MOTORNET TECHNOLOGIES, in order to determine what MOTORNET TECHNOLOGIES services are the most popular. This data is used to deliver customised content and advertising within MOTORNET TECHNOLOGIES to customers whose behaviour indicates that they are interested in a particular subject area.

#### Use of Cookies

The MOTORNET TECHNOLOGIES website use cookies to help you personalise your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programmes or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the web server that you have returned to a specific page. For example, if you personalise MOTORNET TECHNOLOGIES's pages, or register with the MOTORNET TECHNOLOGIES site or services, a cookie helps MOTORNET TECHNOLOGIES to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same MOTORNET TECHNOLOGIES website, the information you previously provided can be retrieved, so you can easily use the MOTORNET TECHNOLOGIES features that you customised.

You have the ability to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. ### Clear Gifs (Web Beacons/Web Bugs)

We employ or our third party tracking utility partner employs a software technology called clear gifs (a.k.a. Web Beacons/Web Bugs), that help us better manage content on our site by informing us what content is effective. Clear gifs are tiny graphics with a unique identifier, similar in function to cookies, and are used to track the online movements of web users. In contrast to cookies, which are stored on a user's computer hard drive, clear gifs are embedded invisibly on web pages and are about the size of the full stop at the end of this sentence. We do not tie the information gathered by clear gifs to our customers' personally identifiable information.

### Flash LSOs

We use local shared objects, also known as flash cookies, to store your preferences such as volume control, or display content based upon what you view on the MOTORNET TECHNOLOGIES site to personalize your visit. Third parties, with whom we partner to provide certain features on our site or to display advertising based upon your web browsing activity, use flash cookies to collect and store information.

Flash cookies are different from browser cookies because of the amount of data and type of data used, and also because of how data is stored. ### Security of Your Personal Information

MOTORNET TECHNOLOGIES secures your personal information from unauthorized access, use or disclosure. MOTORNET TECHNOLOGIES secures the personally identifiable information you provide on computer servers in a controlled, secure environment, protected from unauthorized access, use or disclosure. When personal information (such as a credit card number) is transmitted to other websites, it is protected through the use of encryption, such as the Secure Socket Layer (SSL) protocol.

MOTORNET TECHNOLOGIES follows generally accepted industry standards to protect the personal information submitted to us, both during transmission and once we have received it. No method of transmission over the Internet, or method of electronic storage, is 100% secure, however. Therefore, we cannot guarantee its absolute security.

### Social Media (Features) and Widgets

Our Web site includes Social Media Features, such as the Facebook Like button and Widgets, such as the Share this button or interactive mini-programmes that run on our site.
